The People Say 'Yes': A Victory for Abortion Rights in Ireland

Dr Ailbhe Smyth, Activist and Academic, Co-Director of Together for Yes is an Irish academic, feminist and lesbian activist. She was a founding director of the Women's Education, Resource and Research Centre (WERRC), University College Dublin (UCD). Smyth began her involvement in activism in the 1970s whilst a student as part of the women's liberation movement. During this time, she became increasingly more politically aware and began following the global women's movement which led her to setting up the Women's Study Forum at the beginning of the 1980's. Later she started the department of Women's Studies in UCD in 1990. Smyth was a spokeswoman and convener for the Coalition to Repeal the Eighth Amendment. She is also a founding member of Marriage Equality, convenor of Feminist Open Forum, an organiser for Action for Choice, a board member of Equality and Rights Alliance and is the former Chair of the National LGBT Federation.



Addressing the Health Consequences of Female Genital Mutilation in Somalia

Ms Ifrah Ahmed, Founder of the Ifrah Foundation (born in Somalia & now an Irish citizen) is one of the world's foremost campaigners and activists against Female Genital Mutilation (FGM) She is the founder of the United Youth of Ireland non-governmental organisation for young immigrants, and the Ifrah Foundation, which is devoted to eliminating FGM. Her work includes raising awareness through producing media content to highlight the negative impact of FGM. In July 2018, in collaboration with the Global Media Campaign to end FGM, Ahmed produced a short documentary on the death of 10 year old girl due to complication resulting from FGM. Since 2016 she has served as Gender Advisor to the Prime Minister of Somalia. Her focus over the past four years has been to deliver programs in Somalia providing evidence-based results that inform Ifrah Foundation's scoping of its proposed national action plan for the eradication of FGM in Somalia.

Health Equity and Rights – Local and Global

Rights and Rites: The potential of alternative rites of passage in contributing to FGM abandonment in Tanzania

Gill Carter, Maastricht University. As part of Carter's MSc in Global Health from Maastricht University in the Netherlands, her master's thesis focuses on alternative rites of passage as a means to end FGM. Originally from Ireland, Gill has a BSc in international development from UCC. Before starting her masters, Carter spent 5 years working with NGOs across Africa but predominantly in Tanzania on SRHR campaigns, comprehensive sexuality education and girl empowerment projects. Over the years, she has worked in a number of roles including; project coordination, program management, operations, campaigns and communications. Together with UNFPA Tanzania, Carter is creating national guidelines for conducting alternative rites of passage as a strategy to end FGM.

Teens, families, communities and clinics: A socioecological approach to reducing teenage pregnancy in rural Sierra Leone

Adèle Fox, Concern is currently the Equality Advisor based at Concern's HQ with a focus on gender transformative programming. 
Learning for Lives Ghana
