


Figure 2: Gestational age on presentation





Figure 3: Maternal age




Figure 5: Perinatal mortality




Figure 6: Time from admission when fluid calibration was measured




Figure 7: % of cases which anti-convulsant and anti hypertensive drugs were administered




Figure 8: Oxygen saturation levels ±95%




Figure 8: Antenatal visits completed by women who developed Pre-Eclampsia




Figure 9: Documented diagnosis on maternity registers
